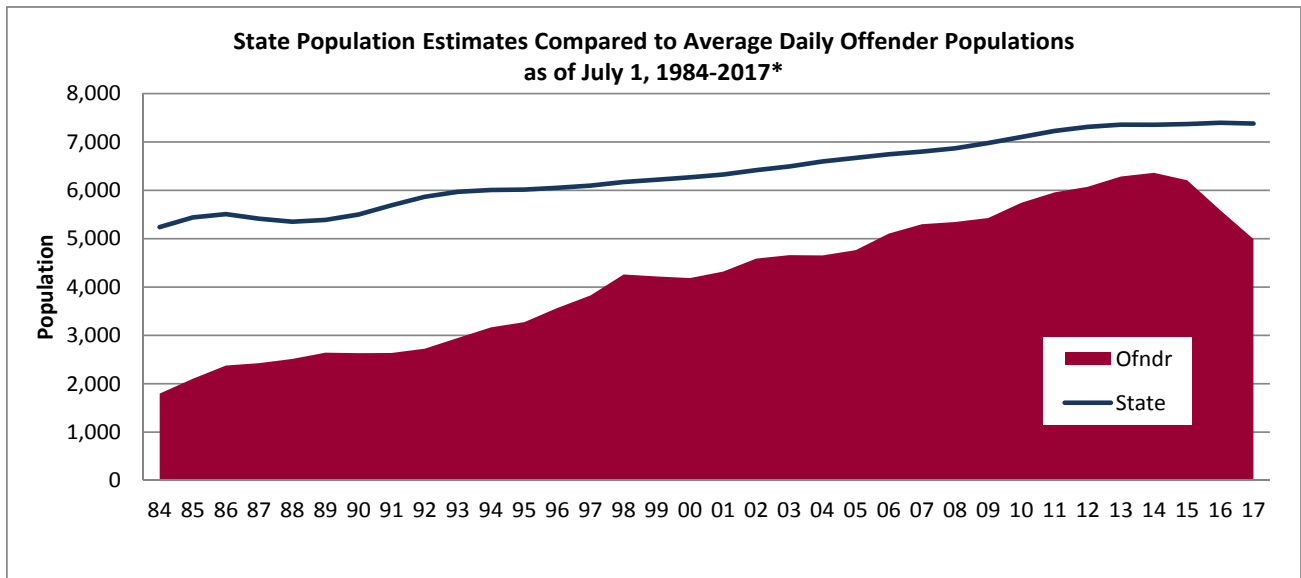

Admissions data includes all criminal admits (except transfers) for all offenders.

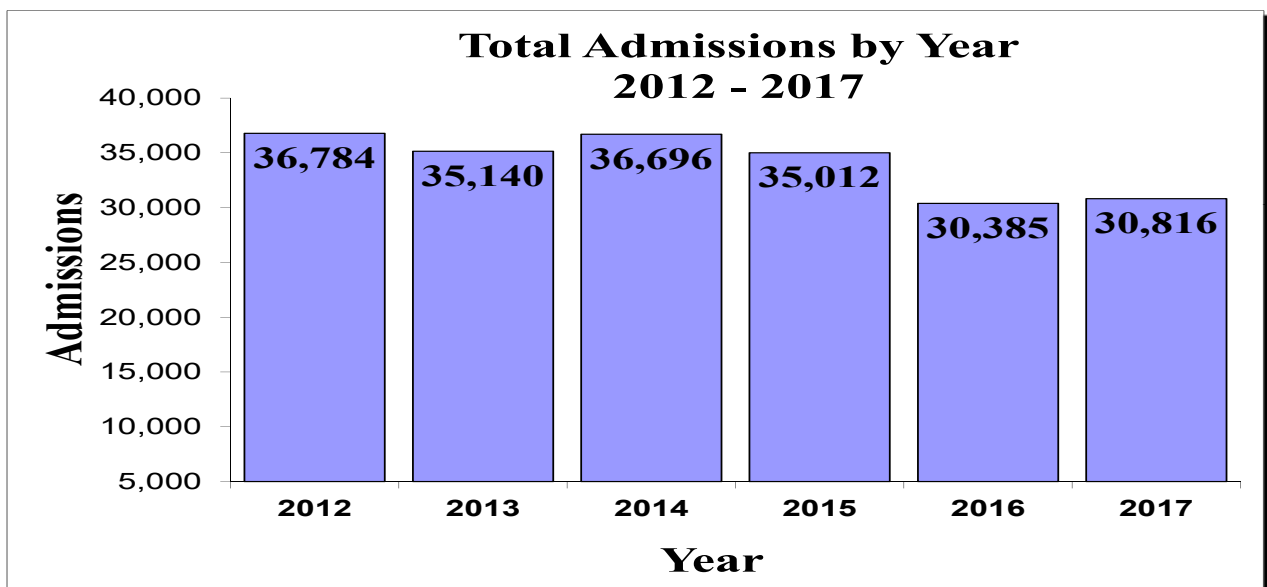
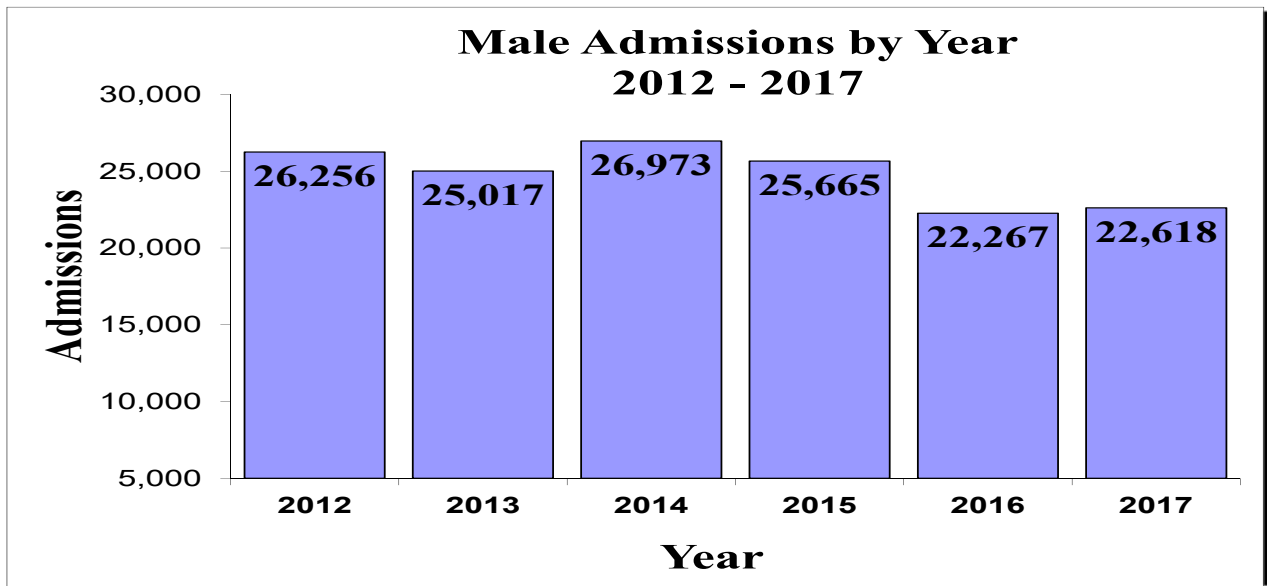
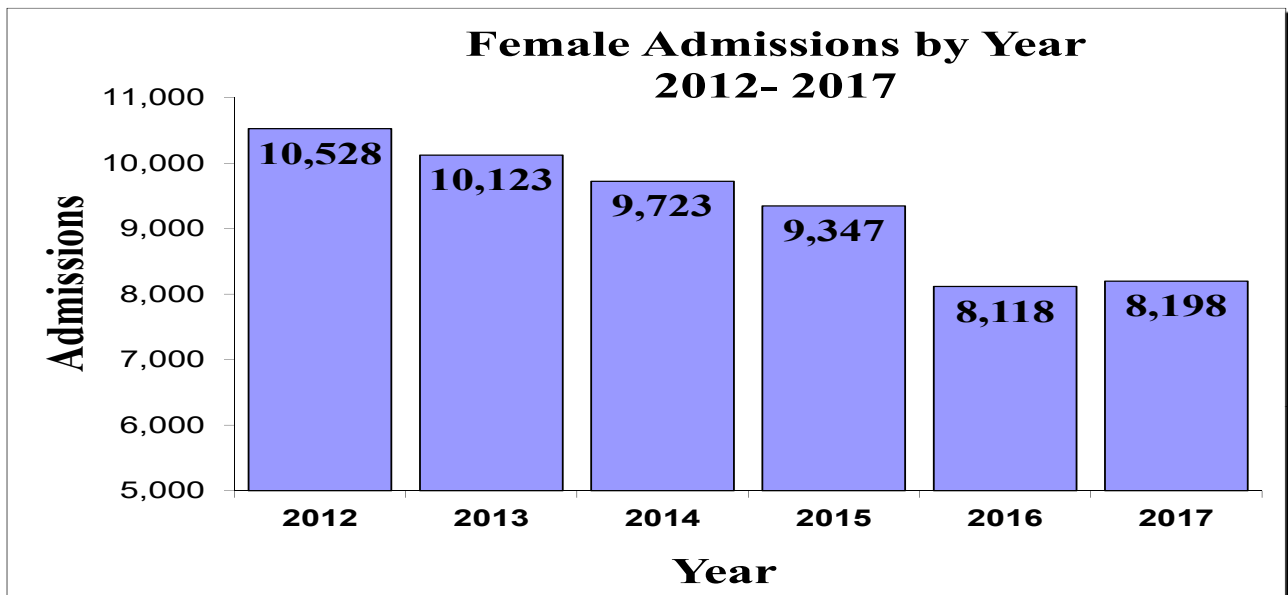

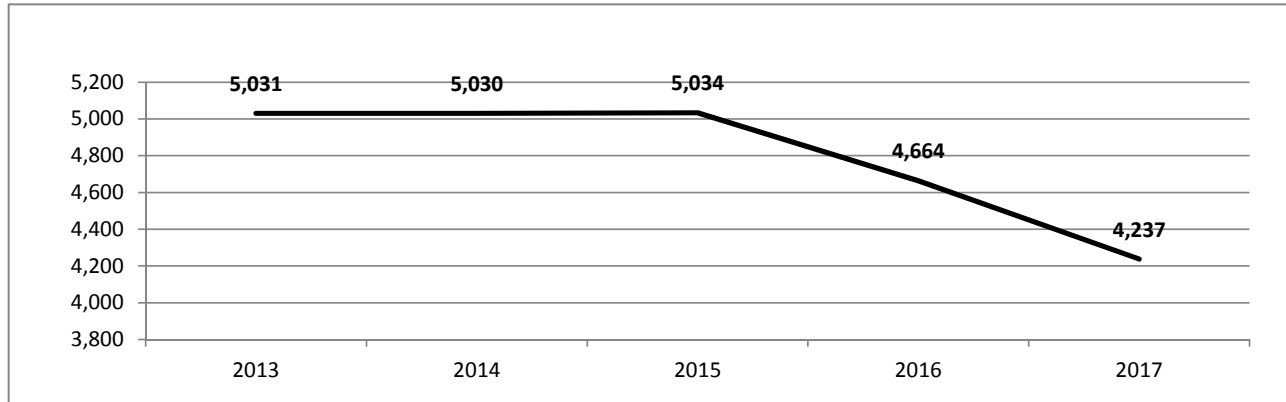
