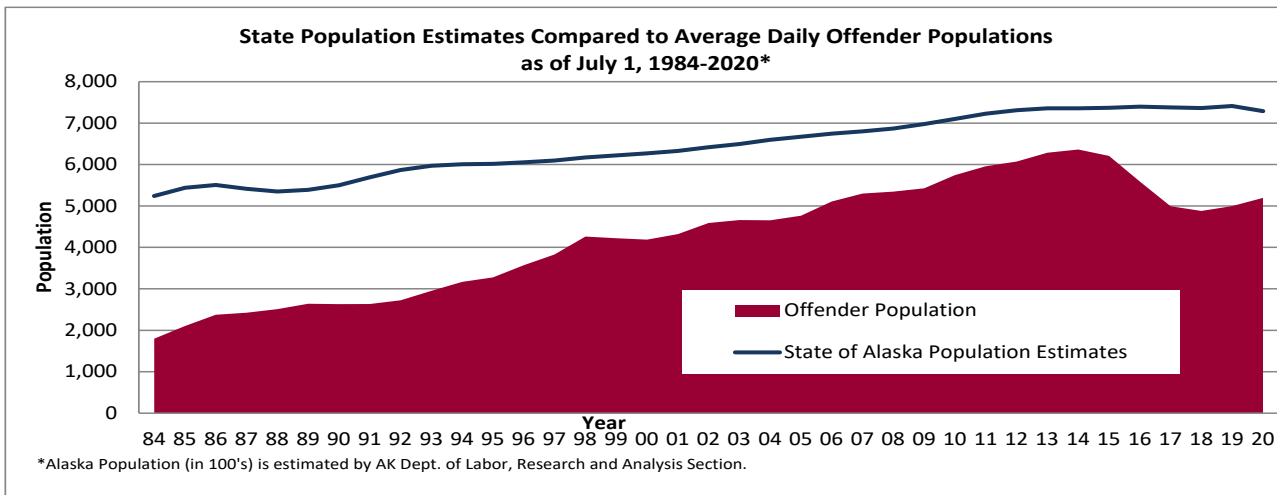

Admissions data includes all criminal admits for all offenders but does not include any transfers from on facility to another.

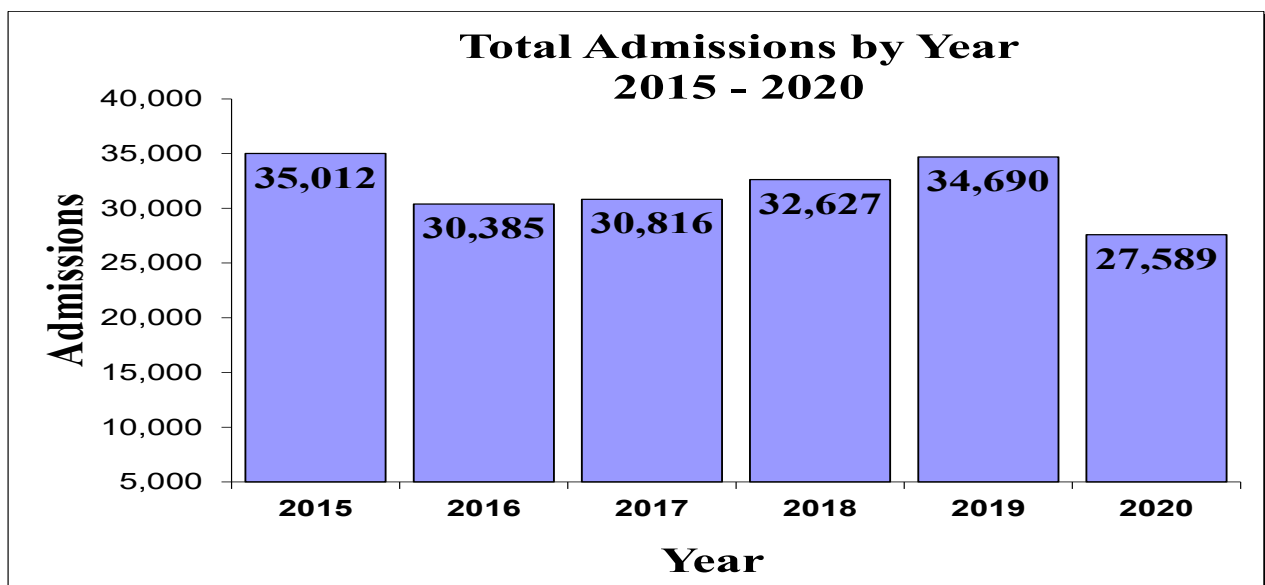
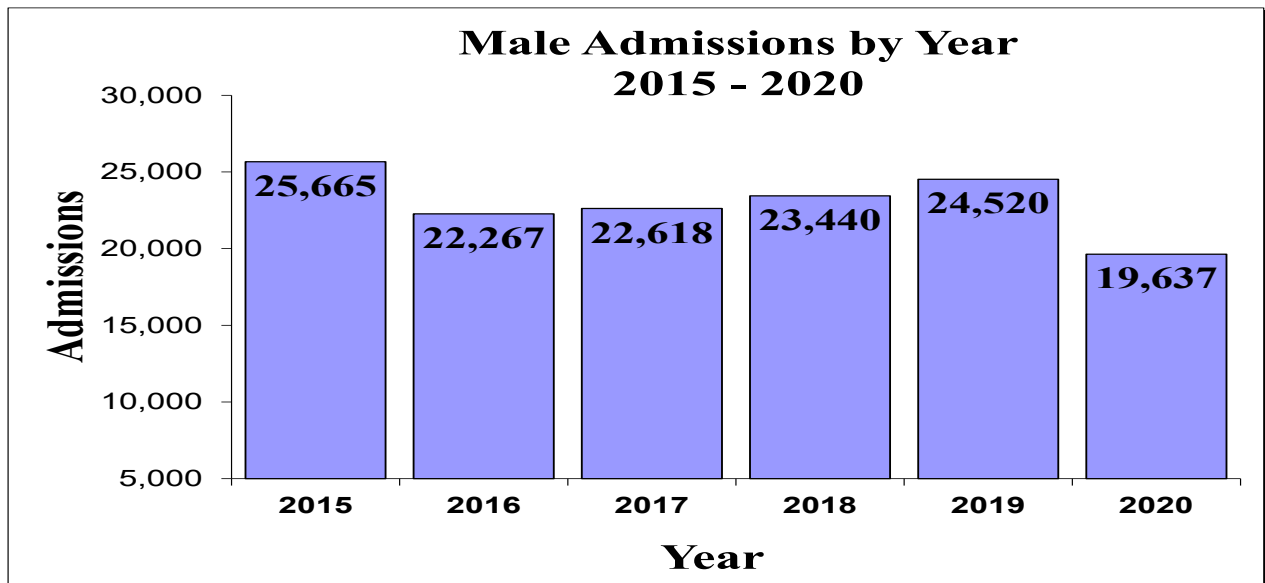
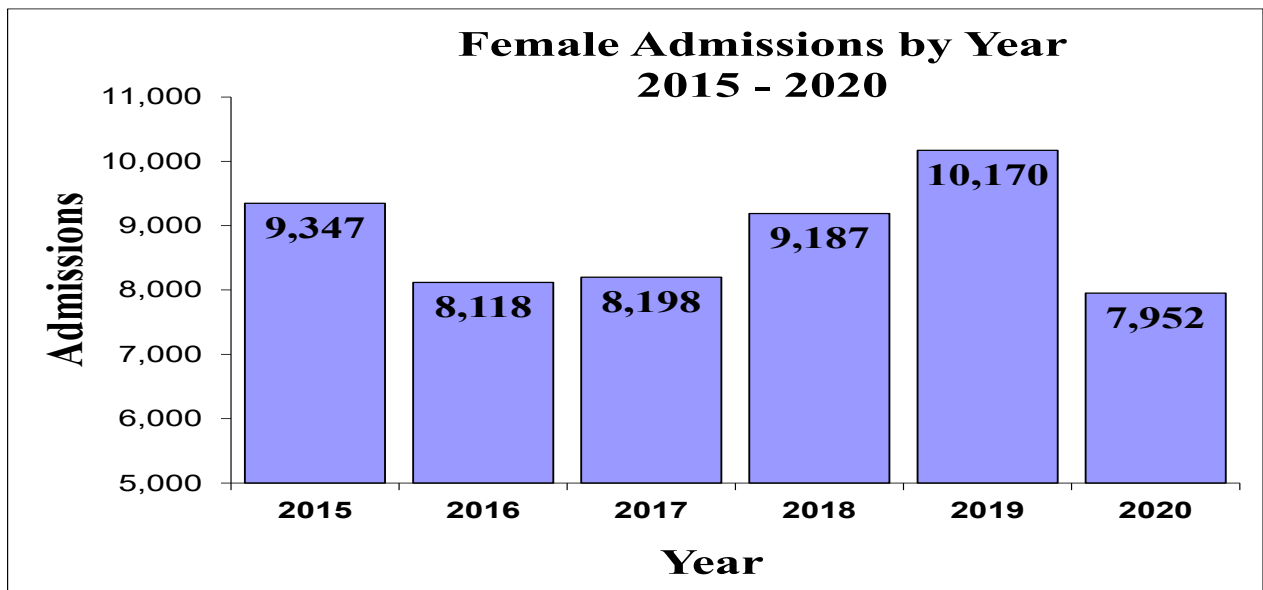

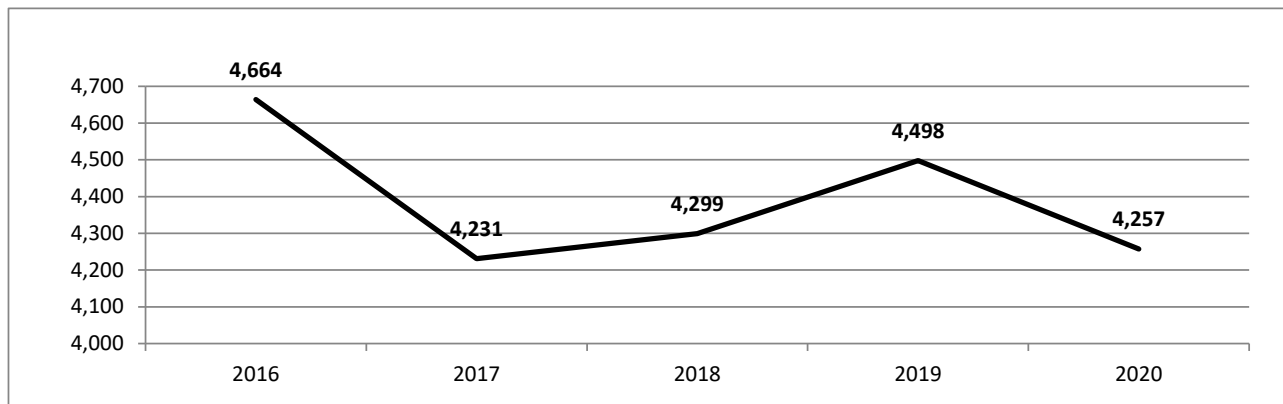

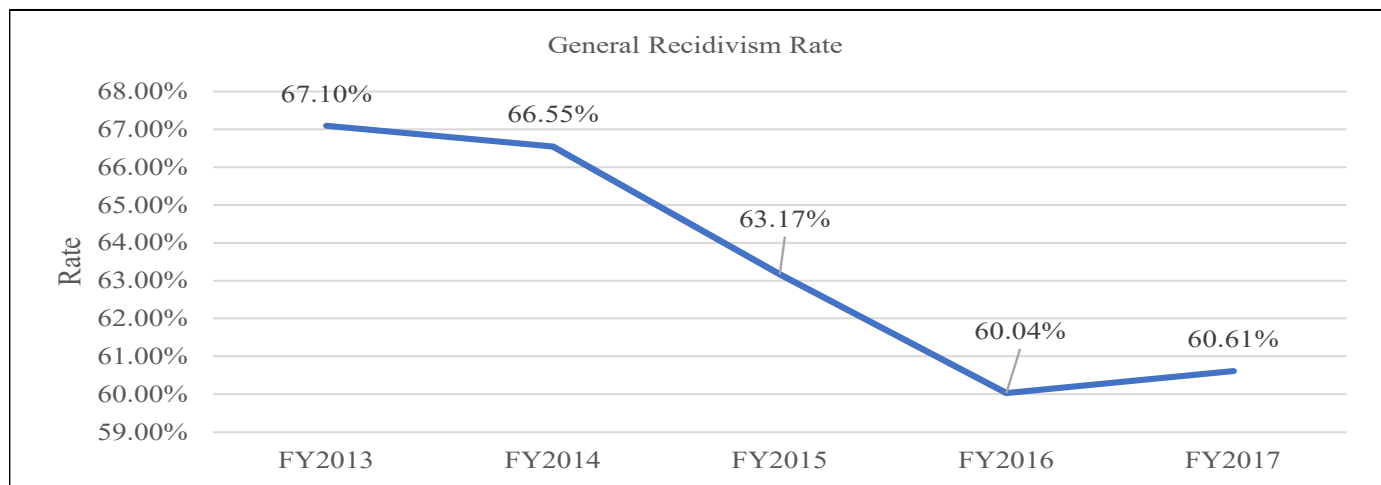
