This report summarizes information obtained from the Offender Tracking Information System (OTIS) about inmates under the jurisdiction of the State of Alaska. Most of the information presented here is obtained from a single day, year-end snapshot. Information about newly incarcerated offenders who were not yet entered into OTIS was not included in this report.

Since OTIS is a dynamic system with offender data being updated at any time from numerous locations, the information presented here may not exactly match that published elsewhere. This report is meant to give a general summary of the offender population not a precise depiction of inmates under the jurisdiction of the State of Alaska.
