- 1. To determine if a surgical mask is certified for use as PPE, look for a standard code printed on the box. The code will begin with different letters depending on the country of manufacture: US-ASTM; EU-EN; China-YY or GB. If the mask has not received a certification indicated by one of these codes it cannot be considered PPE because the ability to protect staff is unknown.
- 2. As local supply allows.
- 3. An N95 is preferred. However, based on local and regional situational analysis of PPE supplies, medical-style face masks are an acceptable alternative when the supply chain of N95s cannot meet the demand. During this time, available N95 masks should be prioritized for medical procedures that are likely to generate respiratory aerosols, which would pose the highest exposure risk to staff.
- 4. A cloth mask is considered source control and not PPE
- 5. Close Contact an individual is considered a close contact if, while NOT wearing PPE, they have been within approximately 6 feet of a COVID-19 case for ≥ 10 minutes OR have had direct contact with infectious secretions of a COVID-19 case (e.g., coughed on, sneezed on, spit at, or yelled at)
